PROPERTY OVERVIEW

The Daniel Perich Group of KW Commercial Real Estate is offering this industrial land for sale in Tannersville. The 138.8-acre property has 135 industrial-zoned acres located a mile from the Tannersville exit of Interstate 80. Site is situated along Possinger Drive with 500 feet of frontage on Route 715. The property is located in Jackson Township and is currently operating as the Streamside Camp & Conference Center with over 40,000 square feet of improvements. North parcels comprise of approximately 82.5 contiguous acres (of which 79.5 acres is zoning Industrial). The southern parcel is 55.5 contiguous acres of industrial zoned land.

LOCATION OVERVIEW

The Pocono Mountains, which has 27.9 million visitors each year, is approximately 2 hours from Philadelphia, Harrisburg or Trenton and 1.5 hours from New York City. Travel spending exceeds \$3.3 billion annually of which 19% is on food and beverage. The Poconos features more than 30 golf courses, 4 indoor waterparks, abundant shopping centers and various seasonal recreational activities. Major area developments include the 130,000 square foot expansion of Kalahari Resort's convention center, and the new Harley Davidson dealership.




Zoning










